

August **9th**, Wednesday, @ **6:30pm** in the "Movie Screening Room", Regency Palms, 1020 Bismark Way, Oxnard. Gather at **6:15** in the front entrance or the back alley parking lot, use front electric door for quick entry and seating. From back alley, call the front desk at (805) 247-0227 to request back door entry assistance.

This facility is only about a year old, very modern, and very nice! The new "*Movie Screening Room*" is equipped with the latest equipment including a premium permanent wall mounted movie theater screen. The padded seats are big and comfortable with armrests and writing tables. The room has heating and air conditioning. *Please! Don't be late! Late arrivals in a dark room can be annoying!*. Try not to arrive inside the facility lobby before 6:15 or after 6:30. The facility has wifi so we will also use **Gotomeeting.com** app for those that cannot attend in person. I suggest you use GPS to drive to Bismark Way. Since driving I have missed the turn from Channel Islands Blvd twice to Concord Dr even using GPS, I recommend you turn onto Albany Dr, its easy to see. Curb spaces are nearly always available in front of the building. There are also 20+ empty parking spaces in the new paved alley *behind* the building, you can park in ones marked <u>"Regency Palms Parking Only</u>".


